Traditionally Public Health would have been looking long term Its about quality of life and people dying early.

Life expectancy varies 10-13 years between the most and least deprived areas

Edinburgh Females high deprivation (77.3 yrs)- Low deprivation (85.9 yrs) Edinburgh Males High deprivation (71.3 yrs)- Low deprivation (83.1 yrs)

COVID-19 mortality 2.4x higher for people living in areas of multiple deprivation - age and ethnicity also mean higher risk

NHS should focus on

Education Income Employment Housing

The NHS should be viewed as an anchor organisation which are rooted in their communities

The Partnership & Place teams have taken a Place-based approach -Evidence shows that addressing the social determinants of health is the most effective way to improve population health

Place-based approach are focused on:

- social determinants of health and 'upstream' interventions
- the importance of prevention
- the importance of early intervention
- the importance of early years
- proportionate universalism

The partnership and Place Teams

Aim: improve population health and tackle health inequalities through strategic and collaborative planning and action

PH role: to support, influence, advise, lead and deliver where appropriate

Approach:

- prevention, addressing wider determinants of health, partnership working, intelligence led, across the life-course

-meaningful presence and relationships within local partnerships – an integral part of the Community Planning system

Consultant led, skills mixed teams - links to public health services/programmes
